**Criteria:**

- Applicant may be any group or organization wanting to prevent child sexual assault in the Appalachian region.
- Recipients must participate in a virtual training with PCAK on how to prevent child sexual abuse and how to use the materials effectively at their agency or organization.
- Feedback (including a survey) regarding the program, training, and materials provided through the mini grant must be given to PCAK.
- Applicant must serve families and/or the community and provide information on preventing child sexual abuse, safe caregivers, and healthy child development to them when sharing the materials.
- Recipient will provide information to PCAK on how they have disseminated materials, how they have been utilized, and any feedback from the families/community that they serve.

*\*PCAK will select 7 recipients based on this criterion, as well as geographical coverage.*

- **Recipients will be notified of award no later than Friday, February 25, 2022.**
